1	Register	Register yourself as a Numera Dealer at http://dealerresources.numera.com/ . This registers you as a Numera dealer and provides you instant access to Marketing Materials, Q&A, product images and other helpful information to become a successful Numera Dealer		
2	Select Central Station	The Dealer must select a Central Station to Monitor Accounts. We have two types of Central stations: Central Stations that Bill for our Monthly services, and Central Stations that do not bill for our Services and we bill the dealer direct.

3	Credit Card Authorization	<p style="text-align: center;">Not Required</p> <p>Complete the Nortek Credit Card Authorization Form</p> <ul style="list-style-type: none"> • Log into https://dealerresources.numera.com (using UN/PW from Step#1)Go to this link: https://dealerresources.numera.com/credit-application • Fill out the form and hit "Submit" 		
4	Reseller Agreement	<p style="text-align: center;">Not Required</p> <ul style="list-style-type: none"> • Once the Nortek Credit Card Authorization form is received you will be sent a link to sign an online reseller's agreement. 		
5	Dealer Training	Next, you will receive a Link to sign up for your free Numera training. Trainings are 90 min duration and occur every Wed and Thursday (excluding holidays).		
6	Verification/ Set Up	After training is complete, Nortek will verify that your organization is set up with an approved MSP/MSPR. You will then be provided log in credentials to the Numera dealer portal. Please allow 1-2 business days after training to receive your log in.		

Note: The entire process may take 1-2 weeks, so please allow adequate time for on-boarding.
